

But one of the most complex and often tedious tasks is dealing with software licensing – it's an essential part of any software implementation, but far too often it gets overlooked.

And no wonder – the wording of many licence agreements can be ambiguous yet, as a customer, you can't afford to get it wrong. Unfortunately, some unscrupulous licensors have been known to use this ambiguity to maximise income for themselves.

In a bid to make their licence agreements as clear as possible IBM have updated their Passport Advantage Agreement and one of the main changes is that IBM customers have to keep clear and accurate records of their software usage.

If you fail to do so you could be liable for a full two-years' maintenance back payment on top of paying for any software licence shortfall.



SOFTWARE LICENSING TOOLS

IBM regularly audits organisations at random to ensure they are compliant with the terms of their Passport Advantage Agreements, checking usage doesn't exceed entitlement.

Any organisation that is found to be non-compliant is liable to pay charges that IBM specifies for:

- Any 'excess use'
- Support for excess use for the lesser of the duration of such excess use or two years
- Any additional charges and other liabilities determined as a result of such verification

IBM isn't just here to rap the knuckles of those who aren't compliant – they have a solution, it's called the IBM License Metric Tool (ILMT).

This free tool helps you maintain an inventory of the PVU (Processor Value Unit) based software for your Full Capacity or Virtualised (Sub Capacity) environment and measures the PVU licence required by software product.



HOW CAN YOU USE ILMT TO IMPROVE EFFICIENCIES AND REDUCE COSTS?

Many are already using ILMT for Sub-capacity licensing - which makes it possible to license a capacity based licensed software program for less than the full processor core capacity of the server, when deployed in an eligible virtualisation environment.


